- Any other issues raised in the briefing pursuant to the schedule; and
- Any other outstanding motions and pleadings, and other issues that the Board deems necessary for issuing a Final Written Decision.

The Board previously scheduled the Oral Argument for this case and related proceedings, IPR2021-00335, -00336, and -00337 on April 12, 2022. Petitioners

is one consolidated hearing to address the issues raised in all four proceedings.

Petitioners also request permission to use audio and visual equipment to

display demonstratives and exhibits (including remotely if necessary) during the oral

hearing.
