Pursuant to 35 U.S.C. §§ 141 and 142 and 37 C.F.R. §§ 90.2 and 90.3, Patent Owner GUI Global Products, Ltd. (“Patent Owner”) hereby provides notice that it appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered June 22, 2022 (Paper 27) and from all underlying findings, orders, decisions, rulings, and opinions, including without limitation, the institution decision entered July 2, 2022 (Paper 11).

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Patent Owner states that the issues for appeal include, but are not limited to: the Patent Trial and Appeals Board (“Board”)’s determinations in the institution decision that there is a reasonable likelihood that claims 1-13 of the ’320 patent are unpatentable and the Board’s subsequent determination that claims 1-13 of the ’320 patent are unpatentable; the Board’s consideration and analysis of the petition, response and untimely reply arguments; expert testimony, prior art, and other evidence in the record; and the Board’s factual findings, explicit and implicit claim constructions, conclusions of law and/or other determinations supporting or relating to the above issues; the constitutionality of the appointment of PTAB judges and whether the IPR process violates due process; as well as other issues decided adversely to Patent Owner in any orders, decisions and rulings.

This notice of appeal is being filed and served concurrently with notices of appeal for IPR2021-00335 involving U.S. Patent No. 10,259,020; IPR2021-00336

involving U.S. Patent No. 10,259,021; and IPR2021-00337 involving U.S. Patent No. 10,562,077.

Pursuant to 35 U.S.C. § 142 and 37 C.F.R. § 90.2(a), this Notice is being filed with the Director of the United States Patent and Trademark Office.
