NOTICE REGARDING WITHDRAWN CLAIMS

On February 24, 2020, Plaintiff UNM Rainforest Innovations ("UNM") filed the instant suit against Defendant AsusTek Computer Inc. ("Defendant" or "Asus"), alleging infringement of United States Patent Numbers 8,249,204; 8,565,326; and 8,265,096. UNM's Complaint asserts that Defendant designs, manufactures, imports, sells, uses, offers for sale, and markets products that operate in and with wireless networks that comply with IEEE 802.1ac ("Wi-Fi"). Certain of the accused Asus instrumentalities UNM identified in the Complaint contain products provided by Intel Corporation ("Intel") and Broadcom Inc. ("Broadcom") that have or provide Wi-Fi capability.

Since that time, UNM has reached resolutions with Intel and Broadcom regarding UNM's allegations of infringement directed at Intel and Broadcom products. As such, UNM hereby withdraws with prejudice all claims, whether known or unknown, against or involving past, current, and/or future (1) Intel and Broadcom products with Wi-Fi capability, and (2) products that incorporate or include Intel and Broadcom products with Wi-Fi capability.
