**ANCORA TECHNOLOGIES INC.'S
MOTION TO ACCEPT LATE FILING**

Patent Owner, Ancora Technologies, Inc. (“Ancora”), submits this motion requesting that the Board accept the late filing of Patent Owner’s Sur-Reply to Motion for Joinder. Due to a docketing error that occurred between the transition of firms representing the Patent Owner, Patent Owner requests a two (2) day extension.

The Board had authorized Patent Owner to file a 7-page Sur-Reply within 10 business days from the filing of the Reply. (Paper 7.)
