The ornamental design for a combined telephone handset with charging unit, as shown and described.

DESCRIPTION

FIG. 3 is a rear elevational view thereof;

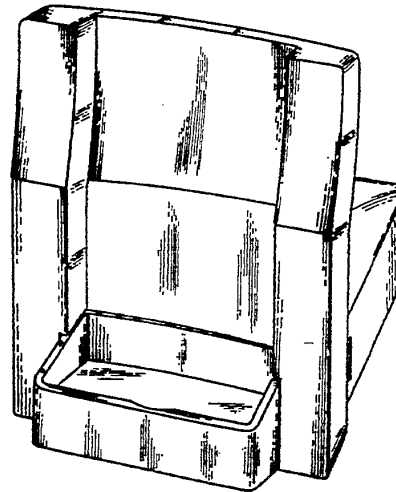
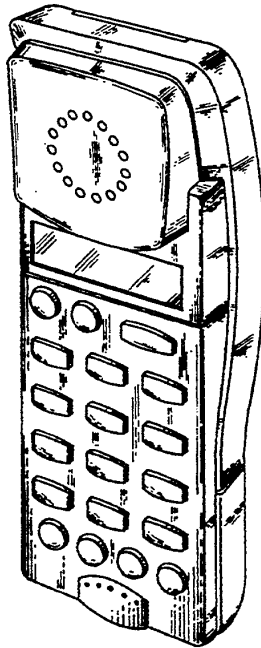
FIG. 4 is a right side elevational view thereof;

FIG. 8 is a front, right side, perspective view showing my new design in which the telephone handset is integrated with the charging unit.



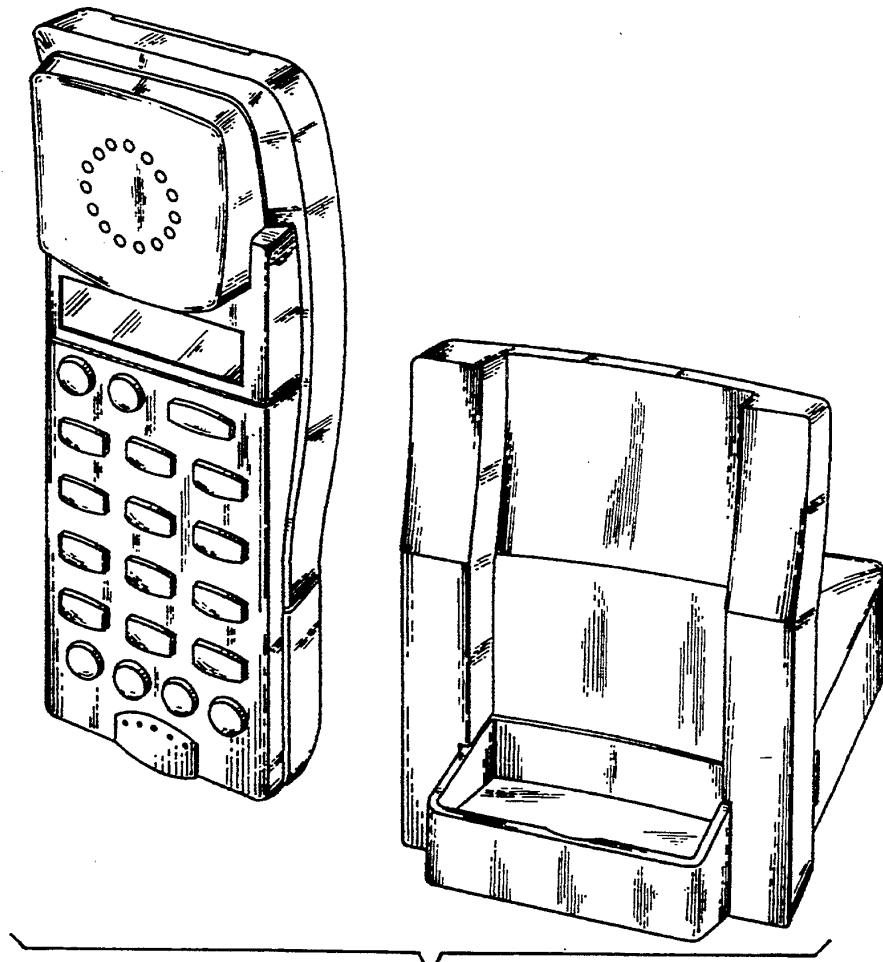

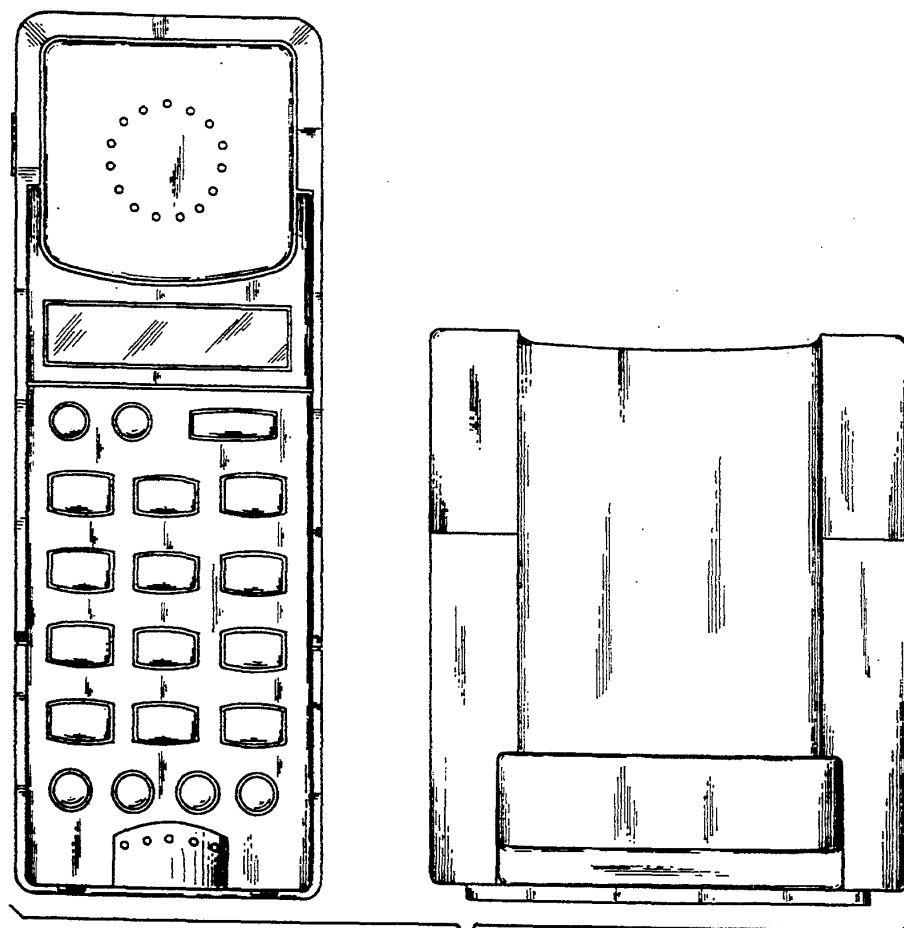

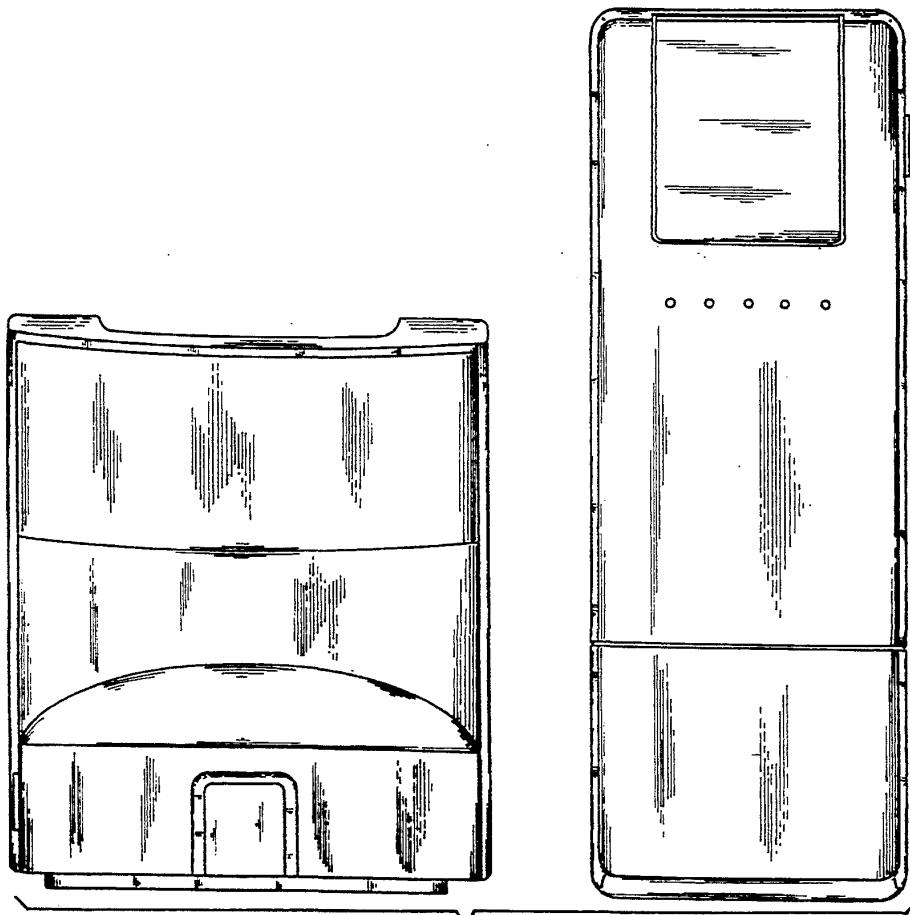

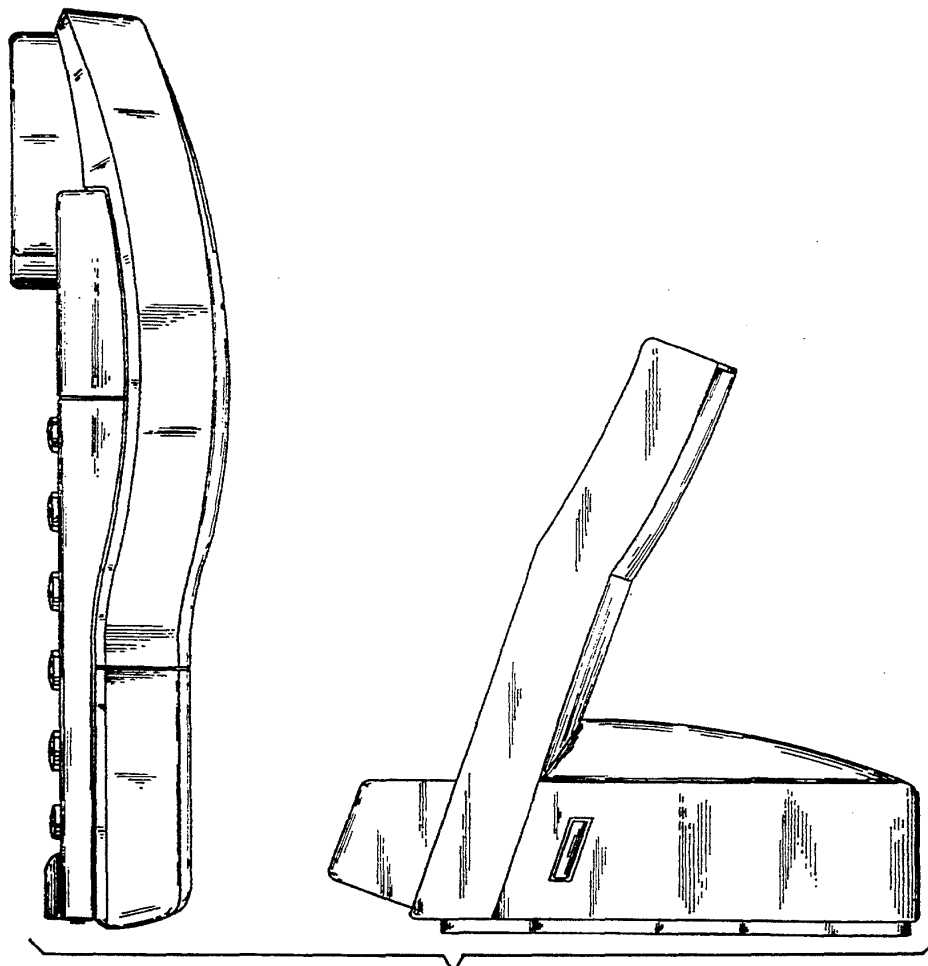
