**PETITIONER'S REQUEST FOR REFUND
OF POST-INSTITUTION FEES**

Petitioner Microsoft Corporation (“Microsoft”) respectfully requests a refund of post-institution fees in the amount of \$22,500.

On May 7, 2021, Microsoft filed a Petition for Inter Partes Review of U.S. Patent No. 8,381,209 (“Petition”). As required by 37 C.F.R. § 42.15(a), Microsoft deposited \$41,500 with the U.S. Patent and Trademark Office (“USPTO”) at the time of filing the Petition in order to cover associated fees. Microsoft’s payment consisted of \$19,000 in fees associated with the Request for Inter Partes Review, and a further payment of \$22,500 in post-institution fees.

On November 8, 2021, the U.S. Patent Trial and Appeal Board issued a Decision Denying Institution of Inter Partes Review (Paper No. 11). Microsoft did not file a request for rehearing. Thus, inter partes review was not instituted. Accordingly, Microsoft requests a refund of the post-institution fees paid to the USPTO in connection with this proceeding, totaling \$22,500, to be paid to deposit account 15-0665 (referencing Attorney Docket 9843.2153/2).
