

ABSTRACT OF THE DISCLOSURE

[0038] Systems and methods of monitoring the heart health of a user are provided. A sensor may continuously monitor the heart rate of the user. The measured heart rate information may be used to determine other parameters such as heart rate variability, heart rate turbulence, and the number or frequency of premature heart beats. The measured heart rate information may also be used to identify and detect arrhythmias. These parameters may be combined to generate a heart health score. Machine learning methods may also be provided to analyze the measured heart rate information to determine heart health and identify atrial fibrillation and/or other heart conditions.
