1. The validity of claims 2 and 3 over *Tayloe* and *TI Datasheet* (Ground I of the Petition).
2. The validity of claims 2-4 over *Lam*, *Enz*, and *Tayloe* (Ground II of the Petition).
3. Any other issue raised in any paper of record in this proceeding.
