August 3, 2022, commencing at 11:01 a.m. EDT, via Video-Teleconference.

3 JUDGE RAEVSKY: Good morning. This is Judge Raevsky.
4 Welcome to the Patent Trial and Appeal Board. We are here today for oral
5 argument and Inter Partes Review No. 2021-01127, in which Momentum
6 Dynamics Corporation is the Petitioner and Witricity Corporation is the
7 Patent Owner.

8 At issue is US Patent No. 9306635B2. Your panel for the hearing
9 today includes myself and Judges Lee and Medley.

10 We'd like to start with appearance. Who do we have on behalf of
11 Petitioners today? Someone may be on mute. I can't hear anyone speaking.
12 Do we have Petitioner Counsel?

13 MR. SLAY: Hello. Party has been admitted.

14 JUDGE RAEVSKY: Hello. Do we have Petitioner Counsel?

15 MR. CHANG: Unmute. Yes. I'm here. This is Dale Chang for the
16 Petitioner.

17 JUDGE RAEVSKY: Thank you, Dale. Were you here for the
18 introduction of the hearing or did you just join in?

19 MR. CHANG: No. We were on, but we didn't see the introduction.
20 I don't know what happened.

21 JUDGE RAEVSKY: Okay.

22 MR. CHANG: Maybe --

1 JUDGE RAEVSKY: I'll start over. It wasn't very interesting, but I'll
2 repeat it for your benefit.

3 MR. CHANG: Okay. Thank you.

4 JUDGE RAEVSKY: I would like to welcome you and everyone to
5 the Patent Trial and Appeal Board. We are here today for oral argument and
6 Inter Partes Review No. 2021-01127, in which Momentum Dynamics
7 Corporation is the Petitioner and Witricity Corporation is the Patent Owner.

8 At issue is the US Patent No. 9306635B2. Your panel for the
9 hearing today includes myself, Judge Raevsky, and Judges Lee and Medley.

10 So let's start with appearances. Who do we have on behalf of
11 Petitioner today?

12 MR. CHANG: Morning. This is Dale Chang. And with me on the
13 public line are John Strang and Blake Davis. We're all from Latham &
14 Watkins, and we represent Petitioner Momentum Dynamics.

15 JUDGE RAEVSKY: And, Mr. Chang, you'll be arguing today?

16 MR. CHANG: Yes, sir.

17 JUDGE RAEVSKY: Thank you. All right. Who do we have on
18 behalf of Patent Owner today?

19 MS. LEUNG: Good morning, Your Honors. This is Kim Leung.
20 And I am joined by lead counsel Josh Griswold. And we represent Patent
21 Owner Witricity Corporation.

22 JUDGE RAEVSKY: And you'll be arguing today, Ms. Leung?

1 MS. LEUNG: Yes, I will.

2 JUDGE RAEVSKY: Okay. Thank you. Before we begin, I have a
3 few reminders. When you're referring to a slide today, please tell us the
4 slide number so that we can follow along. Also, please remember to mute
5 yourself when not speaking, and identify yourself when you begin to speak,
6 for the benefit of the court reporter. And, finally, please be aware that
7 members of the public may be listening to this hearing today.

8 Each side will have 45 minutes to argue its case. We will first hear
9 from Petitioner and then from Patent Owner. Petitioner, would you like to
10 reserve any time for rebuttal today?

11 MR. CHANG: Yes, Your Honor. Fifteen minutes, please.

12 JUDGE RAEVSKY: Okay. Thank you, Mr. Chang. You'll have
13 about 30 minutes for your main argument. And when you're ready, you may
14 begin.

15 MR. CHANG: Great. Thank you. So we'd like to start with a brief
16 overview of the '635 Patent, as well as the Kanno prior art reference and
17 then focus on the disputed issues for each of the two grounds, the first being
18 anticipation by Kanno, and the second being obviousness over Kanno.

19 So turning to slide 2 of Petitioner's Demonstratives, we see that the
20 '635 Patent says that with a wireless charging system, it can be useful to
21 reduce magnetic fields at various distances, including from a few
22 centimeters away from the system to distances much larger from the system,
