PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEES

On July 13, 2021, Samsung Electronics Co., Ltd. and Samsung Electronics America, Inc. (“Petitioner”) filed a Petition for *Inter Partes* Review of U.S. Patent No. 8,526,767 (“the ’767 Patent”), which was assigned AIA review number IPR2021-01254 by the Board. The petition requested *Inter Partes* review of claims 1 through 14 of the ’767 Patent. Accordingly, Petitioner submitted filing fees totaling \$41,500, of which \$22,500 constituted post-institution fees as specified by 37 C.F.R. § 42.15(a).

On January 13, 2022, the Board denied institution of *Inter Partes* Review of U.S. Patent No. 8,526,767, thereby terminating IPR2021-01254. Because *Inter Partes* review of the ’767 Patent in IPR2021-01254 was not instituted, Petitioner requests a refund of post-institution fees in the amount of \$22,500. Upon review and approval of this request, Petitioner respectfully requests that the Board credit these post institution fees to Deposit Account Number 50-0639 from which they were originally submitted.
