ADDITIONAL REQUIREMENTS

<u>Mediation:</u> While certain cases may benefit from mediation, such may not be appropriate for every case. The Court finds that the Parties are best suited to evaluate whether mediation will benefit the case after the issuance of the Court's claim construction order. Accordingly, the Court **ORDERS** the Parties to file a Joint Notice indicating whether the case should be referred for mediation <u>within fourteen days of the issuance of the Court's claim construction order</u>. As a part of such Joint Notice, the Parties should indicate whether they have a mutually agreeable
