Notice is hereby given, pursuant to 35 U.S.C. §§ 141(c), 142, and 319, and 37 C.F.R. §§ 90.2(a) and 90.3(a), that Patent Owner Ancora Technologies, Inc., hereby appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered on January 25, 2023 in IPR2021-01338 (Paper 48), and from all underlying orders, decisions, rulings, and opinions that are adverse to Patent Owner, including, without limitation, those within the Decision on Institution of Inter Partes Review, entered on January 27, 2022 (Paper 9).
