Unified filed an IPR against [U.S. Patent 10,326,987](#), owned by [DivX, LLC](#), a subsidiary of [SoftBank Group Corp.](#), as part of Unified's ongoing efforts in its [SEP Video Codec Zone](#). The '987 patent is being asserted against [Hulu](#) and is directed to encoding alternative streams of video for use in adaptive bitrate streaming.
