On November 23, 2021, the court in *MemoryWeb, LLC v. Apple Inc.*, Case No. 6:21-cv-00531-ADA (W.D. Tex.) issued an order adopting the parties' Agreed Scheduling Order (*i.e.*, PGR2022-00006, EX1061), identifying an Apple trial date of August 7, 2023, and stating that it “expects to set” the trial date “at the conclusion of the Markman Hearing” held on or after June 3, 2022.
