JOINT MOTION TO EXPUNGE



I. INTRODUCTION

Pursuant to 37 C.F.R. § 42.56, Patent Owner MemoryWeb, LLC ("MemoryWeb") and Petitioner Apple, Inc. ("Apple") (collectively, the "Parties") jointly file this Motion to Expunge ("Motion") certain confidential information in the record of this proceeding.

This Motion is timely filed on December 27, 2023, within 45 days of the Final Written Decision (Paper 85) which issued on November 17, 2023. *See* Patent Trial Appeal Board Consolidated Trial Practice Guide November 2019 ("CTPG") at 21-22.
