**PETITIONER’S UPDATED MANDATORY NOTICES  
UNDER 37 C.F.R. § 42.8**

Pursuant to 37 C.F.R. § 42.8, Apple Inc. (“Petitioner”), hereby provides the following updated mandatory notices regarding related matters.

The ’576 Patent was previously the subject of *LoganTree LP, v. Apple Inc.*, 6:21-cv-00397, W.D. Tex. (APPLE-1004).

On May 16, 2022, that district court proceeding was transferred from the Western District of Texas to the Northern District of California as *LoganTree LP, v. Apple Inc.*, 5:22-cv-02892, N.D. Cal.

In addition, the ’576 Patent is or has been the subject of at least eight other district court proceedings since 2015, including *LoganTree LP, v. LG Electronics, Inc. et al.*, 4:21-cv-00332, E.D. Tex., Apr. 27, 2021; *LoganTree LP, v. Huawei Technologies USA Inc. et al.*, 4:21-cv-00119, E.D. Tex., Mar. 25, 2021; and *LoganTree LP, v. Fossil Group*, 1:21-cv-00385, Mar. 16, 2021. See APPLE-1031-APPLE-1037.

Petitioner filed the IPR2022-00037 Petition concurrently with another petition for IPR of the ’576 Patent (IPR2022-00040).

IPR2017-00256, IPR2017-00258, IPR2018-00564, and IPR2018-00565 were previously filed against the '576 Patent by different parties unrelated to Petitioner. IPR2017-00256 and IPR2017-00258 were dismissed prior to institution, and IPR2018-00564 and IPR2018-00565 reached final written decision. Petitioner is not aware of any other disclaimers, reexamination certificates, or IPR petitions addressing the '576 Patent.
