The Order Setting Oral Argument in each of these proceedings stated that "demonstratives shall be served on opposing counsel at least seven (7) business days before the hearing date [of June 2, 2023] and filed no later than three (3) business days before the hearing." Paper 24 ("Order"), 3.² The Order also notified the parties that they "may stipulate to an alternative schedule for serving and filing demonstratives, and request that the Board modify the schedule for filing and serving demonstratives at least seven (7) business days before the hearing date." *Id.* at 3 n.5.

In an email to the Board on May 16, 2023, the parties indicated that they have conferred and they jointly request that the deadline for serving demonstratives be changed to May 26, 2023, and the deadline for filing demonstratives with the Board be changed to June 1, 2023, in view of the upcoming Memorial Day holiday. The request is *granted*.

Accordingly, it is:

ORDERED that, for both proceedings, the deadline for serving demonstrative exhibits on opposing counsel set forth in the Order Setting Oral Argument is modified to be May 26, 2023, and the deadline for filing demonstrative with the Board set forth in the Order Setting Oral Argument is modified to be June 1, 2023.
