The designated attorneys of BC Law Group are Brett Cooper, as lead counsel, and John Petrsoric, as backup counsel. Paper 20. Mr. Cooper and Mr. Petrsoric had represented Patent Owner as attorneys of RAK. Paper 14 (Patent Owner's Second Amended Mandatory Notices).

In summary, Patent Owner requests that RAK be withdrawn and that Mr. Cooper and Mr. Petrsoric (now of BC Law Group and previously of RAK) continue to represent Patent Owner. *See also* IPR2022-00118, Papers 19, 20, 27; IPR2022-00120, Papers 17, 18, 22.
