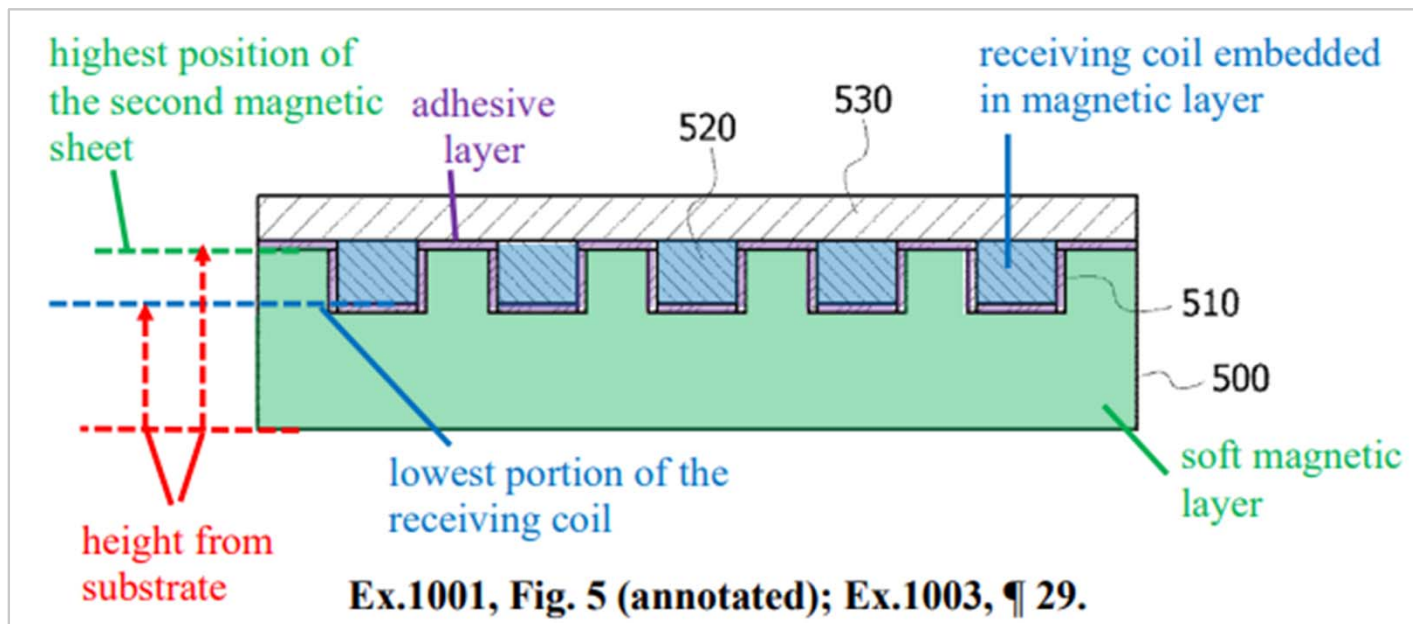

## '962 Patent, Claim 1

The invention claimed is:

. A wireless power receiving antenna comprising:  
substrate;

soft magnetic layer comprising a first magnetic sheet  
disposed on the substrate and a second magnetic sheet  
disposed on the first magnetic sheet;

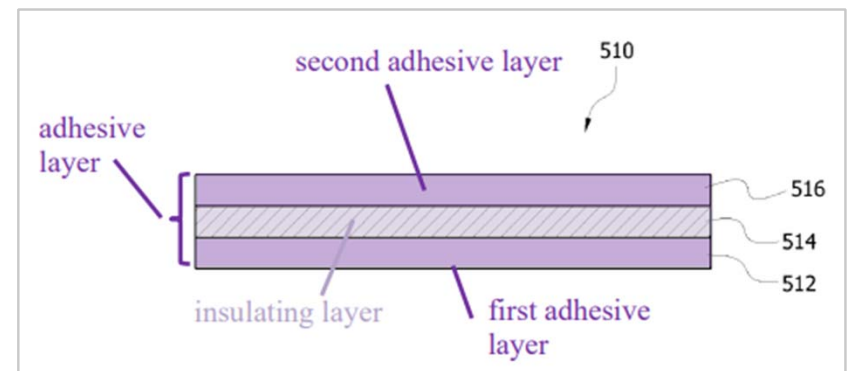
receiving coil disposed on the second magnetic sheet;  
and

an adhesive layer formed between the second magnetic  
sheet and the receiving coil,

wherein the adhesive layer includes a first adhesive layer  
in contact with the second magnetic sheet, a second  
adhesive layer in contact with the receiving coil, and an  
insulating layer disposed between the first adhesive  
layer and the second adhesive layer, and

wherein a height of a highest position of the second  
magnetic sheet from the substrate is higher than a  
height of a lowest position of the receiving coil from  
the substrate.

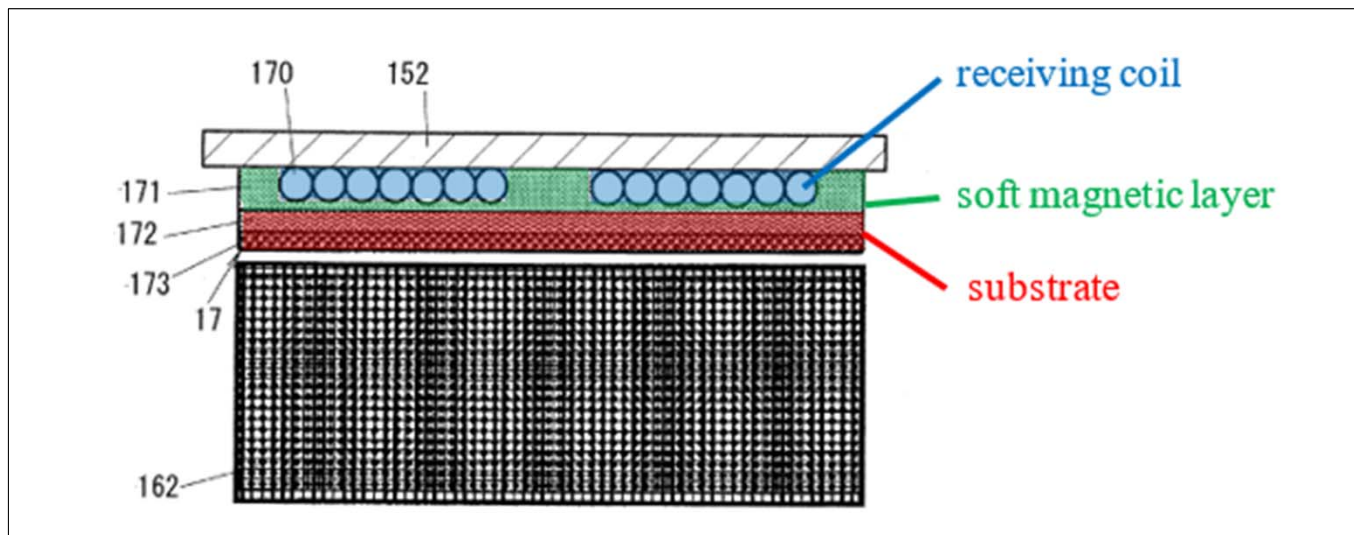
