I. INTRODUCTION

Dr. Rhyne, Plaintiff’s rebuttal expert, disputes one—and only one—aspect of Defendant’s expert, Dr. Freedman’s, mappings of the sole independent claim of each of the ’319, ’510 and ’511 Patents to the prior art reference, Crowds. Ex. N (Rhyne Rebuttal Rep.) at ¶¶ 173-185, 576-588. Dr. Rhyne asserts only that jondo “4” cannot be a “server.” *Id.* As discussed in the concurrently-filed Motion to Strike Dr. Rhyne, the Court’s prior claim construction orders have addressed and rejected the bases for Dr. Rhyne’s contention—that “a server cannot be a client device” and a user computer cannot be “interchangeable” with a server. Setting those arguments aside, summary judgment of invalidity follows directly.

There is no fact issue that Crowds’ jondo “4” is “operating in the role of a server,” which the Court held is the “correct” criteria for determining if a device is a server. Ex. C (Supplemental CC Order) at 7-11. Dr. Rhyne’s report does not dispute Dr. Freedman’s analysis on this point. And Dr. Rhyne provided matching testimony as to: (1) his view on what functionality is “sufficient” to be a server and (2) the functionality of jondo “4” that he agrees Crowds discloses:
