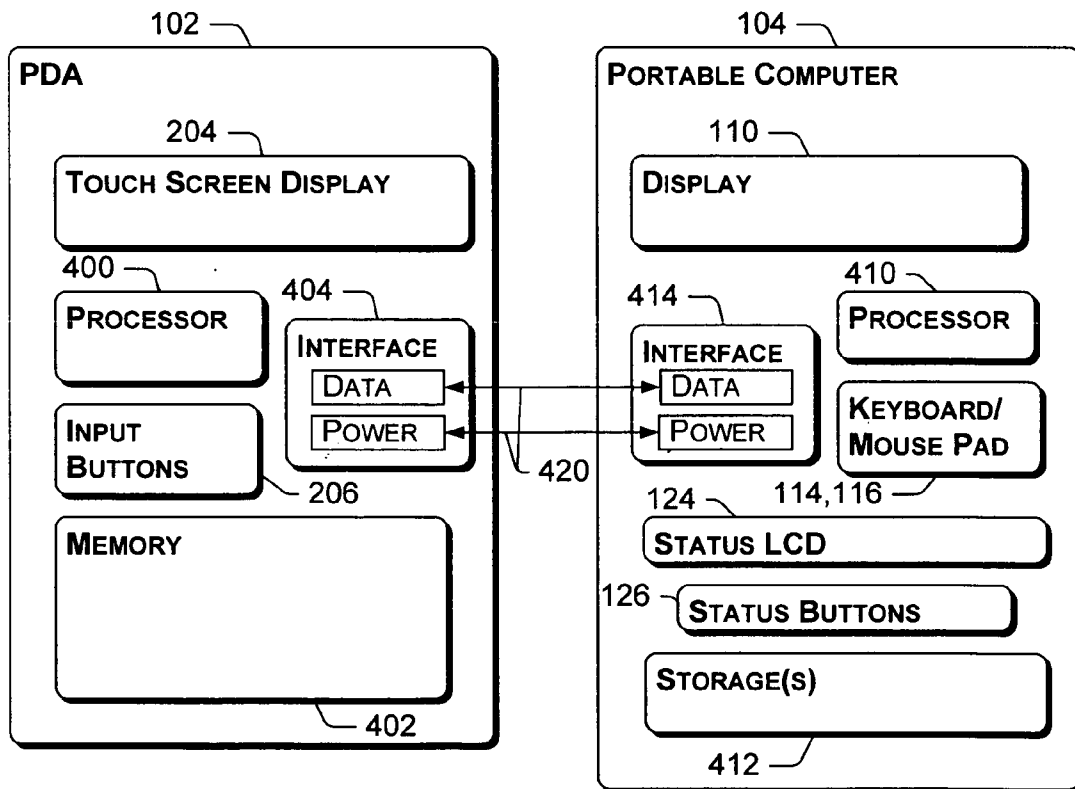

The disclosure relates to computer systems. One example is a portable computer having a housing, a processor and memory mounted within the housing. 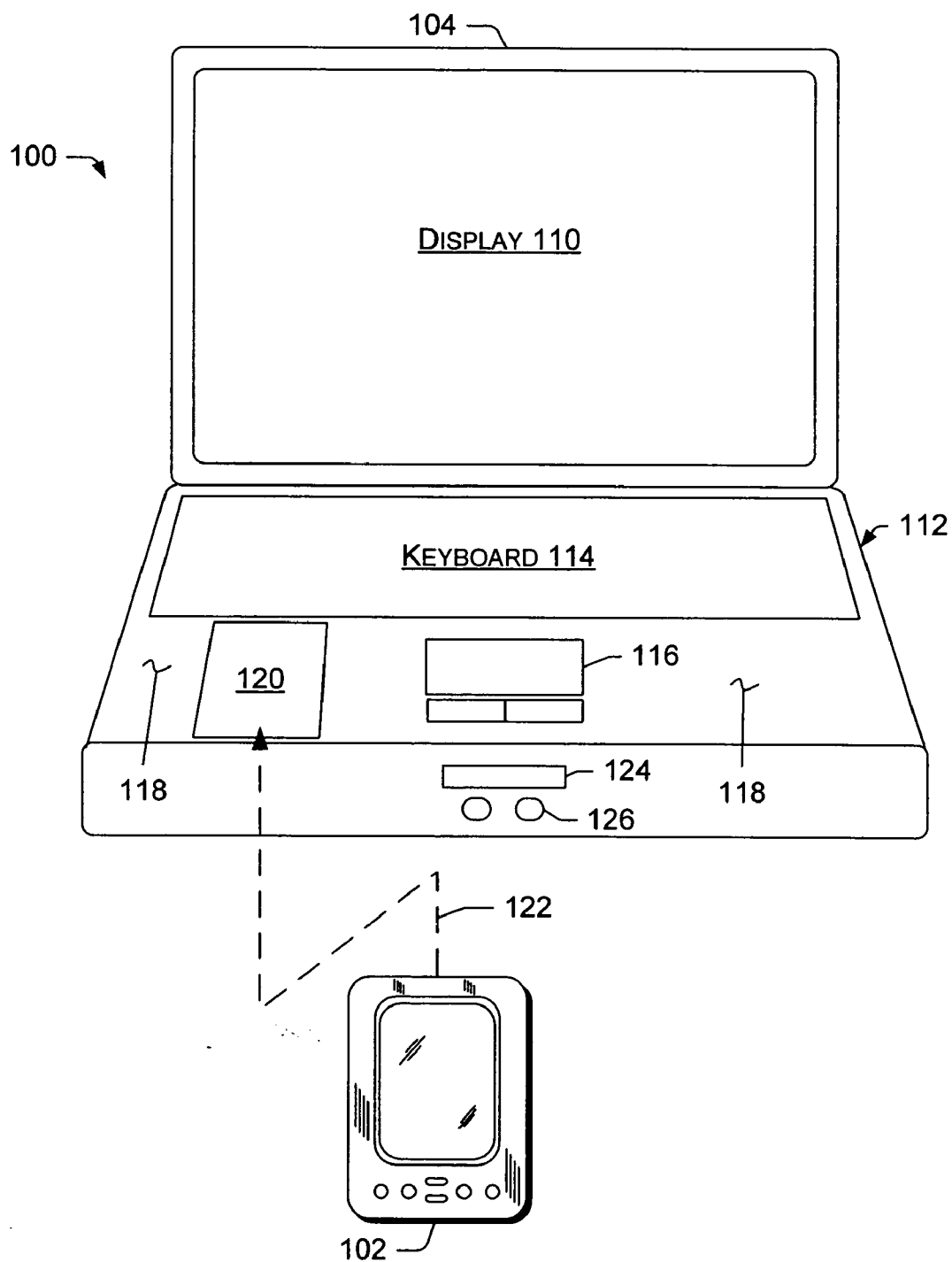

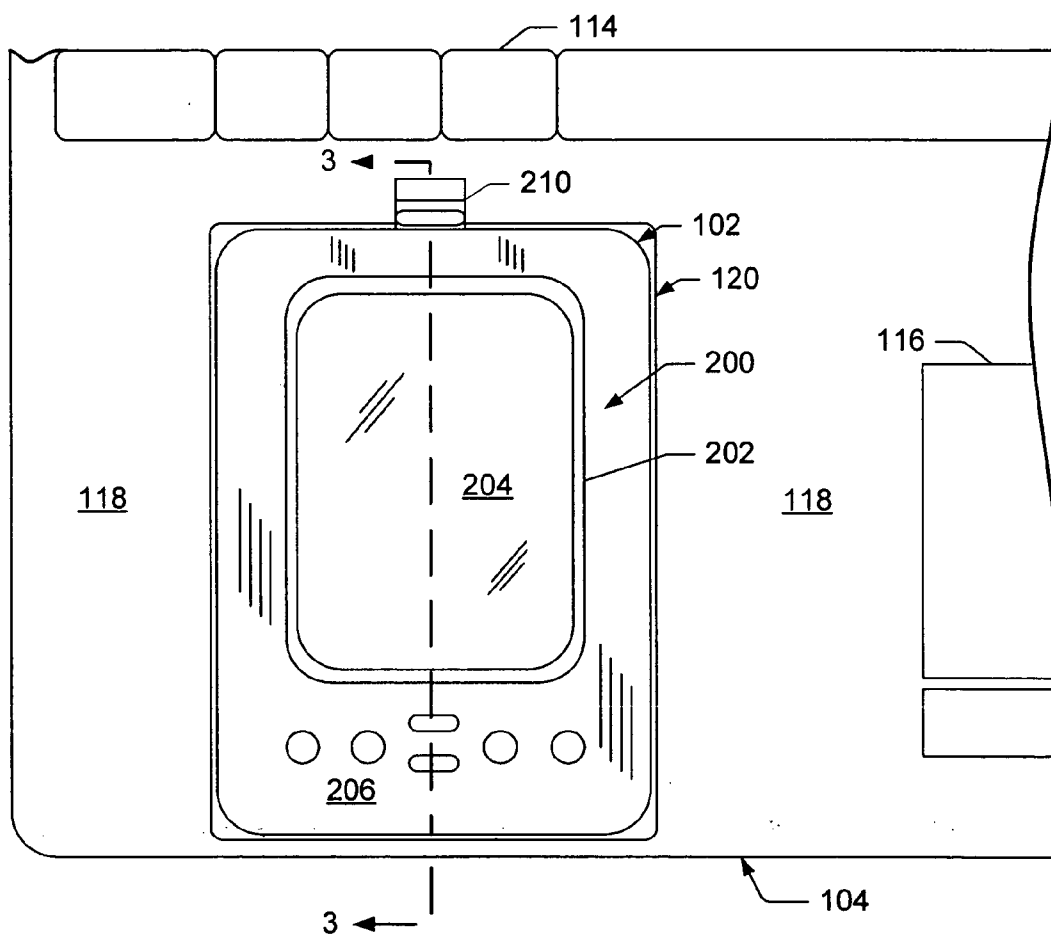

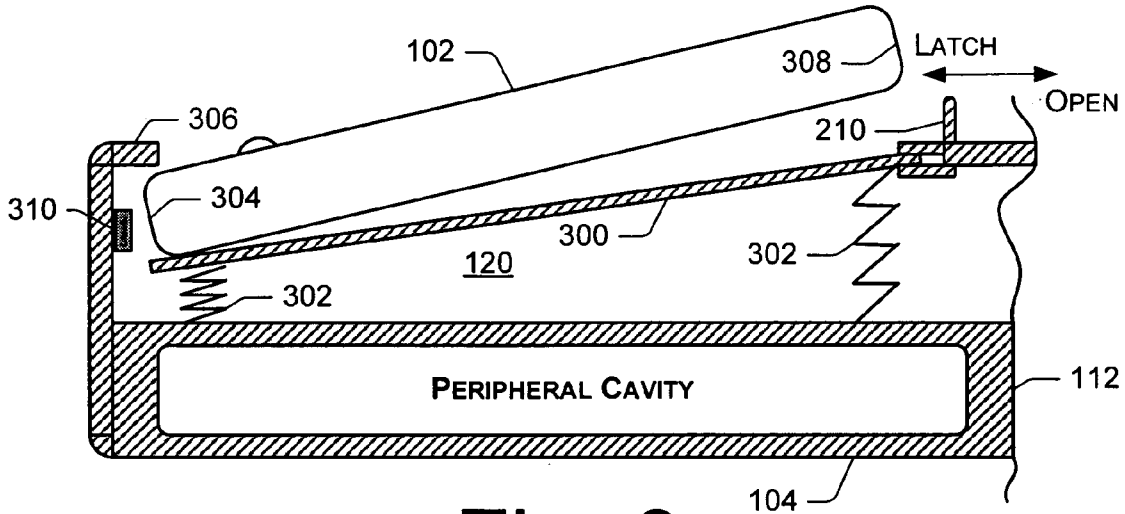

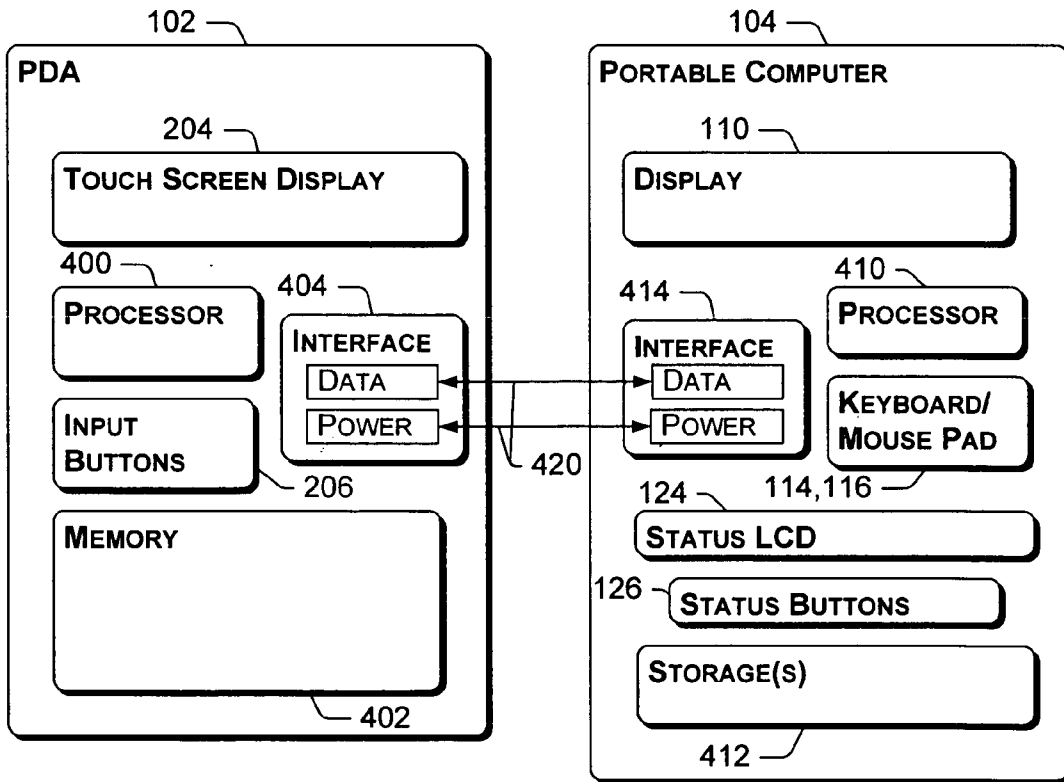

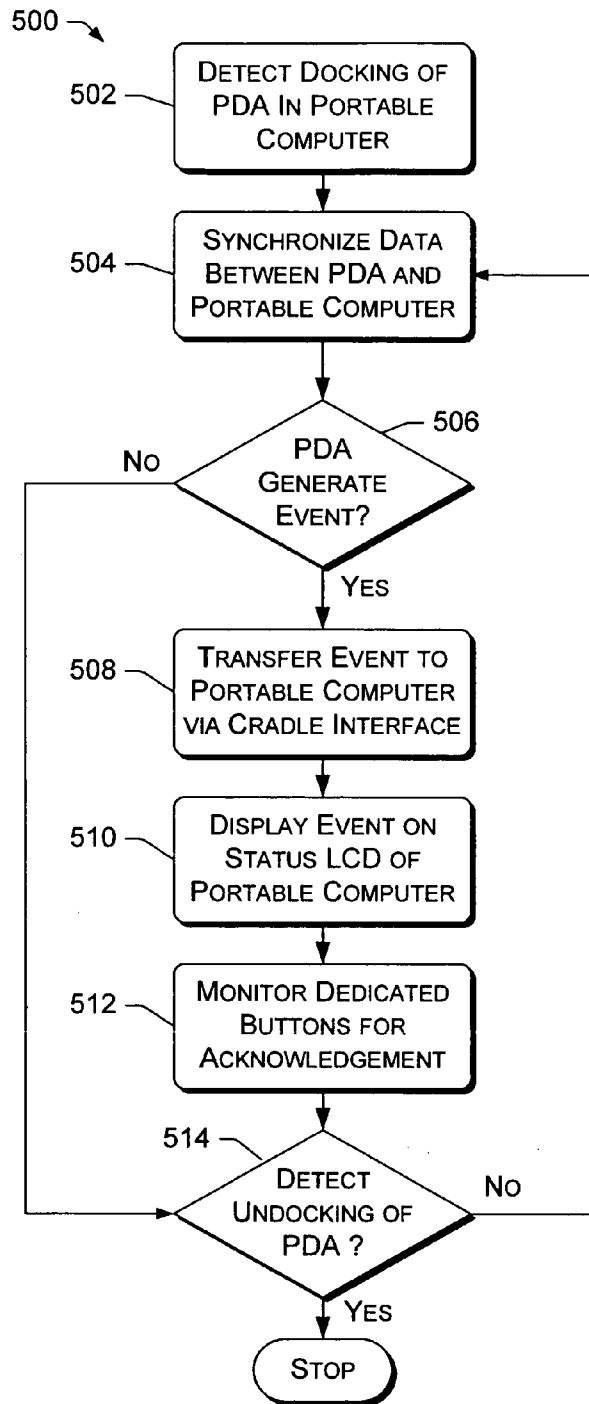
