PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEES

Pursuant to the Patent and Trademark Office's Final Rule Setting and Adjusting Patent Fees, 78 Fed. Reg. 4212, 4232–4234 (Jan. 18, 2013), Petitioner, Apple Inc., requests a refund in the amount of \$42,750 to be credited to Deposit Account Number 06-1050.

On November 15, 2021, Petitioner filed a Petition for *Inter Partes* Review of U.S. Patent No. 10,469,934 with the Patent Trial and Appeal Board that was assigned case number IPR2022-00188. In accordance with the fee schedule specified in 37 C.F.R. § 42.15(a), Petitioner deposited an electronic payment in the amount of \$19,000 with the Board at the time of filing its Petition to cover associated fees with Petitioner's *inter partes* review request, and a further \$22,500 in Post-Institution fees and \$20,250 for Post-Institution of each claim in excess of 20.

On April 14, 2022, the Patent Trial and Appeal Board entered a Decision denying institution of this proceeding. Accordingly, Petitioner requests a refund in the amount of \$42,750 for the post-institution fees that it has paid to the USPTO and requests that the refund be credited to Deposit Account No. 06-1050.
