I. RELIEF REQUESTED

Pursuant to 37 C.F.R. § 42.10(c), Patent Owner Scramoge Technology Ltd., respectfully requests that the Patent Trial and Appeal Board admit John PetrSORIC *pro hac vice* in this proceeding. Patent Owner has conferred with Petitioner, and Petitioner has stated that it does not oppose this motion.

II. GOVERNING LAW, RULES, AND PRECEDENT
