## Level of Skill of a POSITA

- ▶ Petitioner's proposal adopted by the Board at Institution as "consistent with the '787 patent and the asserted prior art":

A POSITA in the field of the '787 patent at the time of the effective filing date would have been knowledgeable regarding mobile payment methods and systems pertinent to the '787 patent. Such a POSITA would have had at least a bachelor's degrees in computer science, computer engineering, electrical engineering or an equivalent, and one year of professional experience relating to mobile payment technology, which would have exposed them to concepts like GlobalPlatform and SmartMX. Lack of professional experience could be remedied by additional education, and vice versa. Ex-1003, ¶¶27-28.
