PETITIONER'S REQUEST FOR ORAL ARGUMENT

1. Whether Claims 1, 3-7, 9-11, and 13 are obvious under § 103 over U.S. U.S. Patent Application Publication No. 2004/0123113 to Mathiassen, et al. ("*Mathiassen*") in view of U.S. Patent No. 6,766,456 to McKeeth ("*McKeeth*") and U.S. Patent No. 6,509,847 to Anderson ("*Anderson*");



- 2. Any claim constructions, unpatentability grounds, or other issues raised in the Petition or Petitioner Reply, the Patent Owner Preliminary Response, the Patent Owner Response, the Patent Owner Sur-Reply, or the Board's Institution Decision;
- 3. Any issues regarding motions to exclude or motions to strike that may be filed or pending; and
 - 4. Any issues otherwise raised by the Board.
