BACKGROUND

In each of the proceedings that are the subject of this Order, as authorized by the Board, the parties filed a Joint Motion to Terminate, copies of related license and escrow agreements, and a request that the related license and escrow agreements be treated as business confidential information. Those related license and escrow agreements included redactions (“Redacted Agreements”).

On September 27, 2022, by e-mail the parties requested that we extend to these proceedings an order that addressed similar circumstances in several other proceedings. *See, e.g.*, IPR2022-00241, Paper 17. The parties’ request is granted.

ORDER

Consistent with the process followed in other proceedings with similar circumstances it is:

ORDERED that Patent Owner shall, within five business days from October 11, 2022 (i.e., by Tuesday, October 18, 2022) file an unredacted version of the Redacted Agreements, in each of IPR2022-00874, IPR2022-00875, IPR2022-00876, and IPR-00877, and designate the corresponding access as “Board only.”

FURTHER ORDERED that the unredacted version of the Redacted Agreements, when filed, will be treated as confidential business information under 35 U.S.C. § 317(b) and 37 C.F.R. § 42.74(c).
