- Q. And Tesonet, founders of Oxylabs, please tell the jury

- 20 | A. So I met him actually online in internet. He was from a
- 21 | small village in Lithuania, and I was from Vilnius. And from
- 22 | my early days, I was spending time online and we chatted. I
- 23 | think we chatted for the first six years. We met in person
- 24 only after he came to Vilnius to study in Vilnius University
- 25 as well.



- Q. And did -- what did you do together? Did you eventually get work together?
- A. Yeah. He -- his background is in computer science, so his bachelor degree is in computer science. But he is a marketing guy.

And I, over the years in internet service provider, taught myself. And I was very passionate about computers.

- 21 A. We have in terms of legal entities or --
- 22 Q. Yes, sir.
- 23 A. So we have Teso LT, Metacluster, you know, Core Cigna,
- 24 and like Core 200 and many others.

- 7 A. Metacluster is Oxylabs' legal entity's name.
- 8 Q. Has Oxylabs grown in the last few years?
- 9 A. Yes, it did.
- 10 Q. Tell us what it's like to work at Oxylabs.
- 11 A. You know, people say that to work to do -- at work we're
- 12 | family, but we really mean it, because one of the first
- employees, you know, team members that joined and still is, is
- 14 my wife. She works at HR.
- Eimantas' wife works in marketing. All of my, you know,
