IPR2022-00861 and IPR2022-00862 Petitioner Code200 understands that Patent Owner has reached a settlement with IPR2021-01492 and IPR2021-01493 Petitioner NetNut and that Patent Owner and NetNut may soon or have sought permission to file a Motion to Terminate. Petitioner Code200 has not settled with Patent Owner and does not join in any Motion to Terminate. Accordingly, to the extent the Board
