Petitioner Major Data UAB hereby seeks the Board's leave to file a brief reply to the Patent Owner's Preliminary Response in the following two proceedings: IPR2022-00915 and IPR2022-00916.

In the Patent Owner's Preliminary Responses, which were filed on June 23, 2022, Patent Owner asserts its "concern" about real-party-in-interest issues and refers to related correspondence to which Petitioner has already responded. These are new arguments unrelated to the substantive issues raised in the petition, and they can be briefly addressed.
