Pursuant to 37 C.F.R. § 42.70(a), and the Board's Scheduling Order (Paper 15) and Order of March 2, 2023 (Paper 19), wherein the Board rescheduled the date for oral argument (Due Date 8), Netlist, Inc. ("Netlist") respectfully requests an oral hearing in this matter. Oral argument is currently scheduled for September 11, 2023. 3. Any other relevant issue raised in papers filed in this proceeding, including issues raised in papers yet to be filed; and,
4. Any additional issues on which the Board seeks clarification.

If an in-person oral argument is scheduled, Patent Owner requests the ability to use audio/visual equipment to display demonstrative exhibits, including the use of a computer, projector and screen for a PowerPoint display. In accordance with the Trial Practice Guide, 77 Fed. Reg. at 48768, Patent Owner will contact the Board Trial Division paralegal to discuss this request.
