As noted in the Board's order from September 28, Petitioner reserved the right to seek an increase of the page limitation for the Response to Expert Testimony after Petitioner has had a chance to review Patent Owner's Sur-reply and accompanying declaration from Dr. Duckworth. Accordingly, Petitioner respectfully requests authorization to increase the page limitation from 10 pages to 15 pages given the length of Dr. Duckworth's declaration (77 pages) and the number of issues addressed.

Patent Owner indicates that it opposes Petitioner's request for a 50% increase in page limit for the Response to Expert Testimony because Petitioner has not shown good cause for the increase since the Sur-Reply was within the 5,600 word limit, Dr. Duckworth's Sur-Reply declaration was substantially shorter than the corresponding Reply declaration, and no additional exhibits were introduced.
