UNDER 37 C.F.R. § 42.8**

Pursuant to 37 C.F.R. § 42.8, Apple Inc. ("Petitioner"), hereby provides the following updated mandatory notices regarding related matters.

On December 12, 2022, Masimo asserted ten patents against Apple in the U.S. District Court for the District of Delaware (Case No. 1:22-cv-01378-MN), including the '127 Patent that is the subject of IPR2022-01299 and -01300, the '501 Patent that is the subject of IPR2022-01271 and -01272, the '502 Patent that is the subject of IPR2022-01273 and -01274, the '648 Patent that is the subject of IPR2022-01275 and -01276, and the '745 Patent that is the subject of IPR2022-01291, -01292, -01465, and -01466.

Masimo previously asserted each of the '127, '501, '502, '648, and '745 Patents against Apple at the ITC, in *Masimo Corporation, et al. v. Apple Inc.*, ITC Inv. No. 337-TA-1276. Based on an order issued December 9, 2022, Petitioner anticipates that the ITC will issue an initial determination in that investigation on January 10, 2023.

Petitioner is not aware of any disclaimers, reexamination certificates, or other judicial or administrative matters that would affect, or be affected by, a decision in this proceeding.
