**PETITIONER'S REQUEST
FOR POST-INSTITUTION FEES**

On October 31, 2022, Samsung Electronics Co., Ltd. (“Samsung”) filed a Petition for *Inter Partes* Review seeking review of claims 11-17 and 19-33 of U.S. Patent No. 7,116,710. On May 4, 2023, the Patent Trial and Appeal Board issued its Decision Denying Institution of *Inter Partes* Review (Paper No. 10).

Petitioner challenged 22 claims, and paid post-institution fees, calculated as follows:

- \$22,500 (for up to 20 claims per 37 CFR § 42.15(a)(2)).
- \$1,500 (\$750 for each claim in excess of 20 per 37 CFR § 42.15(a)(4)).

Accordingly, Petitioner is entitled to a refund in the amount of \$24,000, and respectfully requests a refund of that amount.

Payment of these Post-Institution fees was processed through PRPS on October 31, 2022 and charged to Deposit Account 506092. Upon review and approval of this request, Petitioner respectfully requests that the Board credit the post-institution fee to Deposit Account 506092.
