Del.), and it has been asserted in *Merck KGaA et al. v. Aurobindo Pharma USA, Inc. et al.*, Case No. 1:23-cv-00039-GBW (D. Del.), and *Merck KGaA et al. v. Accord Healthcare, Inc., et al.*, Case No. 1:22-cv-00974-GBW (D. Del.).
