- 3. Petitioner's and Patent Owner's Motions to Exclude Evidence, if any;
- 4. Rebuttal of any arguments made by Patent Owner, including any arguments raised in Patent Owner's request for oral argument; and
- 5. Any additional issues on which the Board seeks clarification.

Petitioner respectfully reserves the right to supplement and/or amend the foregoing statement of issues to the extent the Rules permit.

At oral argument, Petitioner intends to use audio/visual equipment to display demonstrative exhibits.
