Novo Nordisk, A/S, requested a conference call to discuss a onemonth extension of all due dates, including the oral hearing date, to accommodate the scheduling of depositions of Petitioner's six declarants that filed declarations in support of Petitioner's Reply. *See* Ex. 3004. Petitioner did not take a position on Patent Owner's request. *Id*.

A conference call was held on June 6, 2024, to discuss the proposed changes to the schedule for this proceeding. During the conference, we authorized the parties to file a joint stipulation concerning the proposed due dates for Due Dates 3 through 7, but took under advisement the change in the oral hearing due date to confirm availability for an oral hearing during the week of August 26, 2024. Counsel confirmed that each would be available for an oral hearing during that week.
