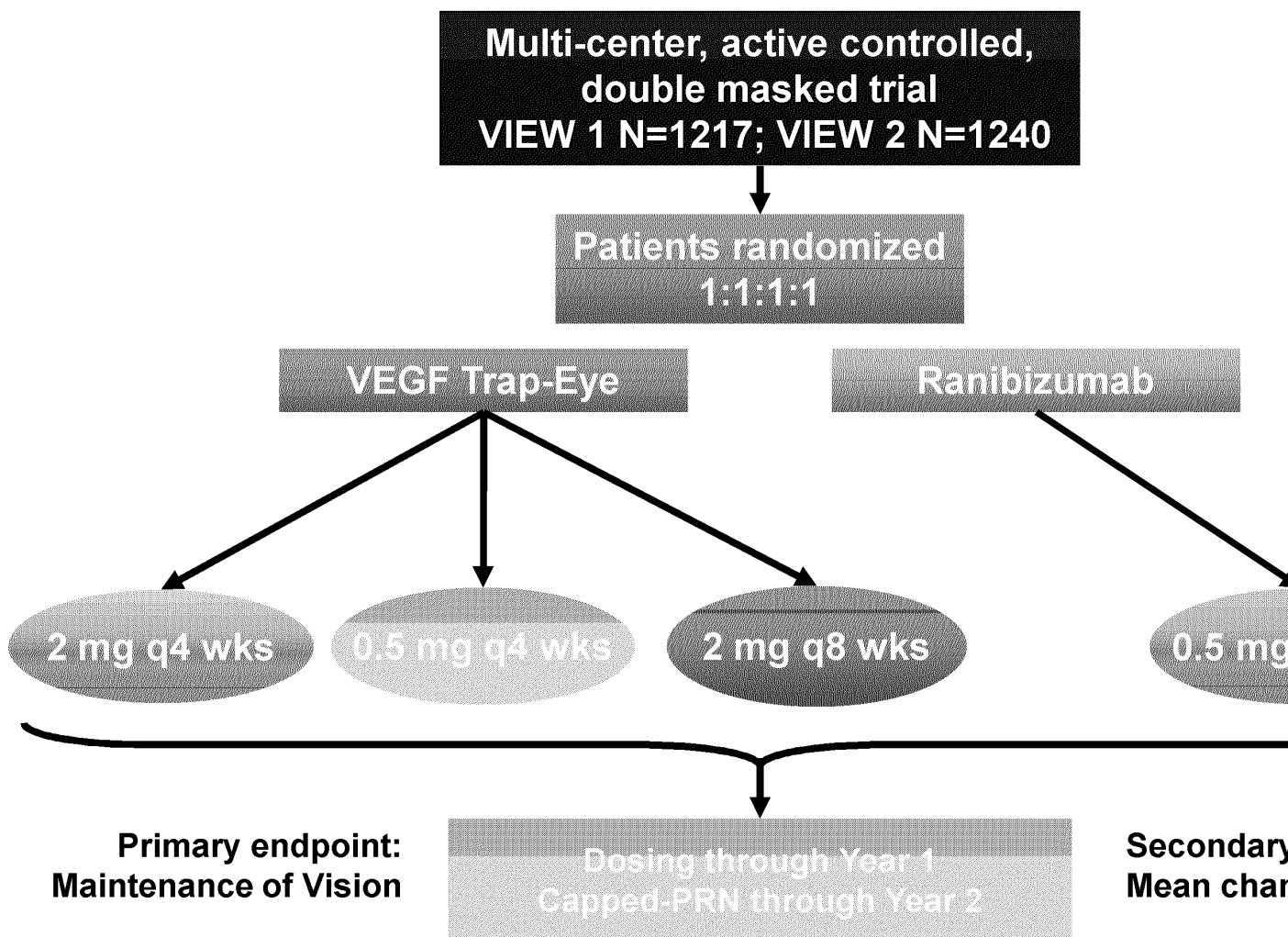

VIEW 1 & VIEW 2 Endpoints

Primary Endpoints:

- Proportion of patients who maintain vision at Week 52, fewer than 15 ETDRS letters vs. baseline

Secondary Endpoints:

- Mean change from baseline in BCVA at Week 52
- Proportion of patients who gain at least 15 letters at Week 52
- Mean change from baseline in total NEI VFQ score at Week 52
- Mean change from baseline in CNV area at Week 52

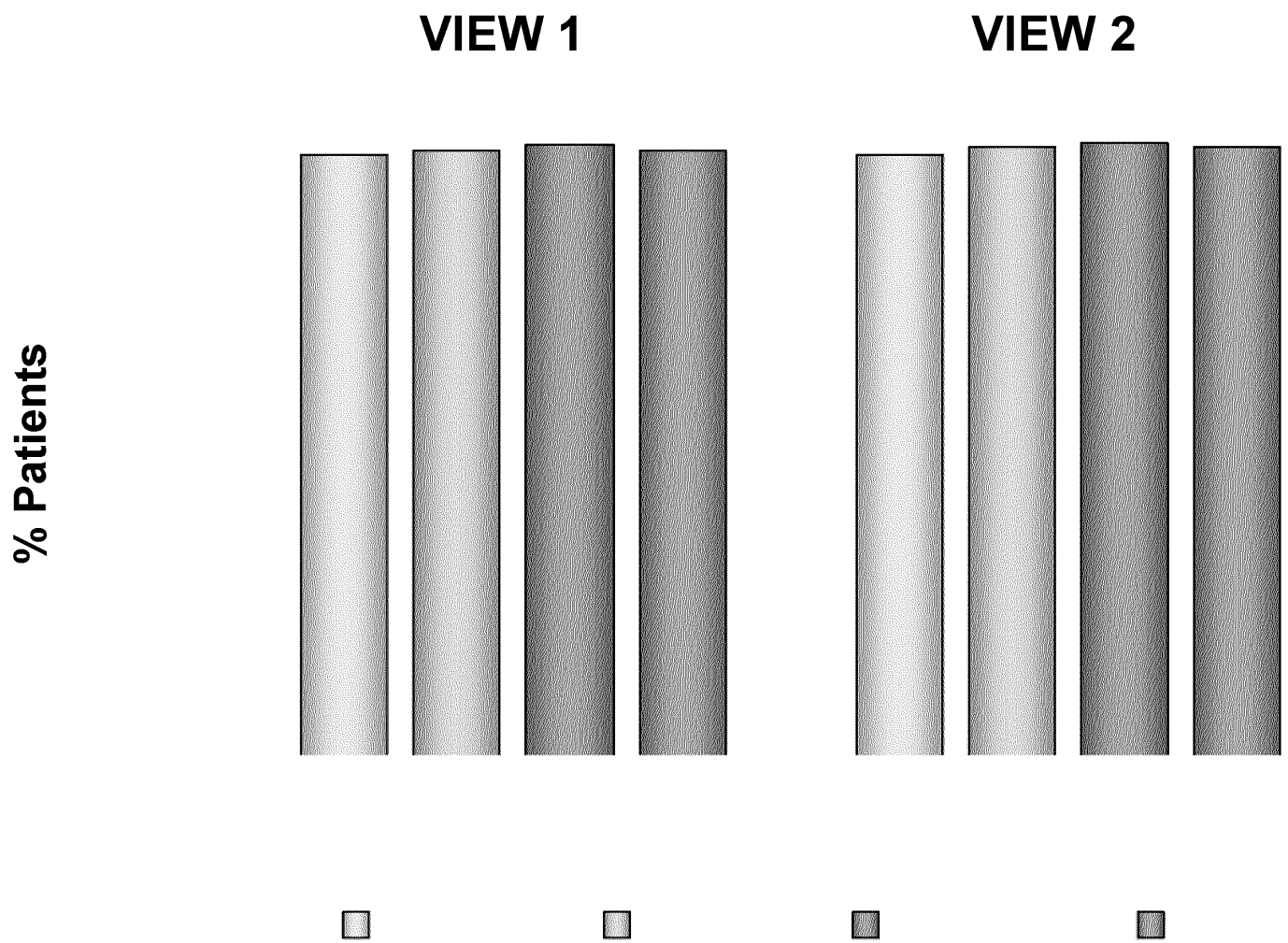
