What Have We Achieved

Status Summary

- ✓ System tests are on track to be delivered & debugged
- ✓ Emulation work in bif & tvout are on track. The completion dates are Jan 24 for tvout and Feb 7 for bif

- ✓ Deliver IDCT final netlist on Jan 24





What Have We Achieved (specs, coding, emulation, tests)


- Coding is 100% complete with 2% outstanding in BIF(agp 64byte write & perf counter).
