AMENDED SCHEDULING ORDER



3/24/2023	4/24/2023	Fact Discovery opens; deadline to serve Initial Disclosures per Rule 26(a).
6/9/2023	6/9/2023	<i>Markman</i> Hearing at 9:00 a.m. This date is a placeholder and the Court may adjust this date as the <i>Markman</i> hearing approaches.
5/18/2023	8/3/2023	Deadline to serve Final Infringement and Invalidity Contentions. After this date, leave of Court is required for any amendment to Infringement or Invalidity contentions. This deadline does not relieve the Parties of their obligation to seasonably amend if new information is identified after initial contentions.
7/13/2023	8/3/2023	Deadline to amend pleadings. A motion is not required unless the amendment adds patents or patent claims. (Note: This includes amendments in response to a 12(c) motion.)
9/21/2023	9/21/2023	Deadline for the first of two meet and confers to discuss significantly narrowing the number of claims asserted and prior art references at issue. Unless the parties agree to the narrowing, they are ordered to contact the Court's law clerks (txwdml_lawclerks_wa_judgealbright@txwd.uscourts.gov) to arrange a teleconference with the Court to resolve the disputed issues.

3 business days before Final Pretrial Conference	3/27/2024	File joint notice identifying remaining objections to pretrial disclosures and disputes on motions <i>in limine</i> .
TBD at the Court's convenience [3/28/2024, or as soon as practicable]	4/1/2024	Final Pretrial Conference. Held in person unless otherwise requested. The Court expects to set this date at the conclusion of the <i>Markman</i> Hearing.
TBD at the Court's convenience [4/22/2024, or as soon as practicable]	4/22/2024	Jury Selection/Trial. The Court expects to set this date at the conclusion of the <i>Markman</i> Hearing.
