**PATENT OWNER'S OBJECTIONS TO EVIDENCE**

Pursuant to 37 C.F.R. § 42.64(b), Patent Owner UNM Rainforest Innovations asserts the following objections to the evidence proffered by Petitioner in its Corrected Ex. 1002. The Federal Rules of Evidence (FRE) apply to these proceedings according to the provisions of 37 C.F.R. § 42.62(a), and these rules form the basis of the objections contained herein.

Patent Owner objects to Corrected EX1002 filed Jan 18, 2024. The alleged “typographical correction” (*see* Attachment A, Johnson email of Jan. 18, 2024) is a substantial material change, as it literally changes the meaning of the relevant assertion to the opposite assertion. Instead of arguing that “the pilot symbols in the legacy transmission (the claimed first communication system) **are denser than** the pilot symbols in the high throughput transmission” (EX1002 ¶195), the change results in the opposing claim that “the pilot symbols in the legacy transmission (the claimed first communication system) **are less dense than** the pilot symbols in the high throughput transmission” (Corrected EX1002 ¶195). This substantive modification presents a material change from the argument presented in the original EX1002, and as such, Corrected EX1002 should be stricken from the record.
