**NOTICE REGARDING WITHDRAWN CLAIMS**

On June 2, 2020, Plaintiff UNM Rainforest Innovations (“UNM”) filed the instant suit against Defendants Dell Technologies, Inc., Dell Inc., and EMC Corporation (collectively “Defendants” or “Dell”), alleging infringement of United States Patent Numbers 8,249,204; 8,565,326; and 8,265,096. UNM’s Complaint asserts that Defendants design, manufacture, import, sell, use, offer for sale, and market products that operate in and with wireless networks that comply with IEEE 802.11ac (“Wi-Fi”). Certain of the accused Dell instrumentalities UNM identified in the Complaint contain products provided by Intel Corporation (“Intel”) that have or provide Wi-Fi capability.

Since that time, UNM and Intel reached resolution regarding UNM’s allegations of infringement directed at Intel products. As such, UNM hereby withdraws with prejudice all claims, whether known or unknown, against or involving past, current, and/or future (1) Intel products with Wi-Fi capability, and (2) products that incorporate or include Intel products with Wi-Fi capability.
