# Joint Proposal Timeline

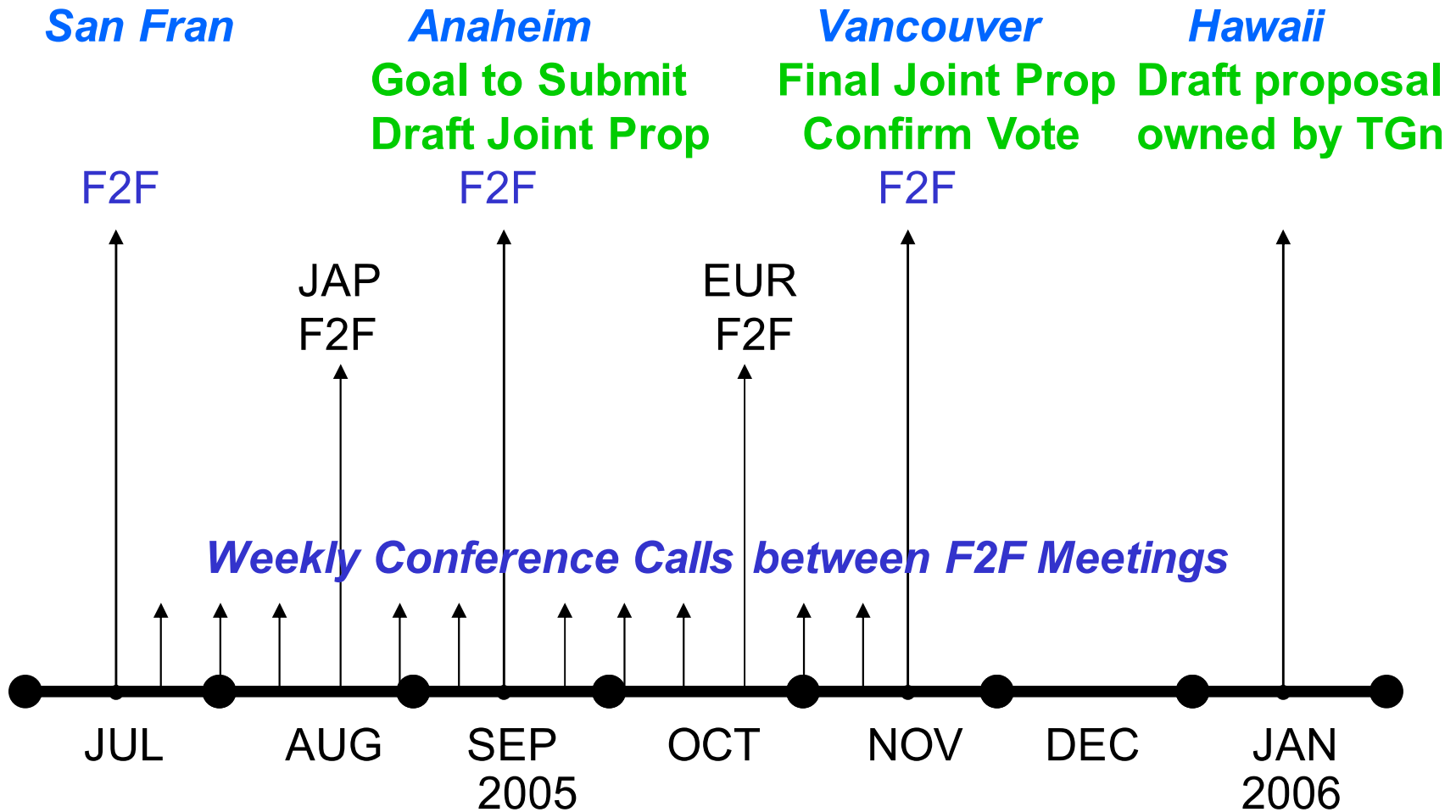
