FIG. 1 is a front elevational view of the brassiere with built-in cell phone pocket showing my new design;


FIG. 2 is a rear elevational view of the brassiere with built-in cell phone pocket thereof;


FIG. 3 is a left-side elevational view of the brassiere with built-in cell phone pocket thereof;

FIG. 4 is a top plan view of the brassiere with built-in cell phone pocket thereof; and,


FIG. 5 is a bottom plan view of the brassiere with built-in cell phone pocket thereof.






