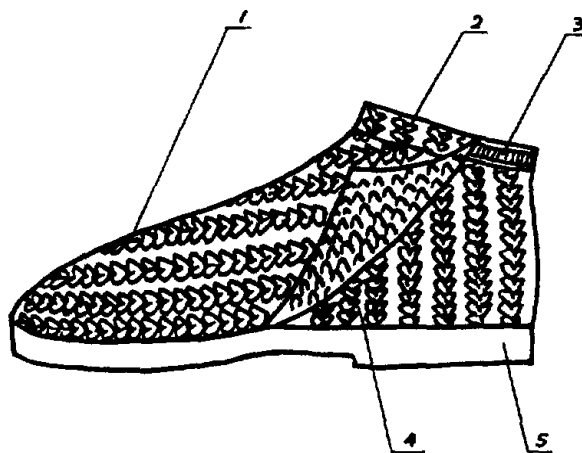

[57]摘要

一种轻便鞋，它由鞋面和鞋底构成，其特点是鞋面用两层具有弹性的绒线编织物制成，鞋面的鞋口处具有定型结构，内装松紧带。本实用新型轻便、透气、保暖、舒适，可广泛用作各年龄段的休闲鞋。



权 利 要 求 书

1. 一种轻便鞋由鞋底、鞋面构成, 其特征在于, 鞋面是由双层具有弹性的绒线编织物制成, 鞋面的鞋口处具有定型结构, 在其内装设松紧带。
2. 如权利要求1所述的轻便鞋, 其特征在于, 鞋口处可以加高, 制成高腰靴型轻便鞋。

说明书

一种轻便鞋

本实用新型属于鞋类。

现有的鞋类品种繁多,每双鞋均由鞋底和鞋面构成,鞋面由皮革、人造革、毡、呢、棉布等为料制成,这些材料由于质地致密,一般强度较大但伸缩性均不大,用这些伸缩性不大的材料制成的鞋为适应不同人的脚的需要,制鞋时,将鞋严格按长度分为多个号;又按人脚的肥瘦程度将每个号又分为多个型,虽有多号多型的鞋,也难完全适应每个人的脚,另外多数鞋重量较大,透气性较差,穿着不舒适。

本实用新型的目的是提供一种伸缩性大,重量轻,透气性好,穿着舒适的轻便鞋。

该实用新型是这样实现的:一种轻便鞋,由鞋底、鞋面构成,其特征在于鞋面是由双层具有弹性的绒线编织物制成,鞋面内外两层的编织花纹方向互为垂直;鞋面的鞋口处具有定型结构,定型结构内装设松紧带。

前述的轻便鞋,其特征不在于鞋口处可以加高,制成高腰靴型轻便鞋。

绒线编织物具有伸缩性大,保暖性和透气性好的特点,因而穿着舒适,但由于其伸缩性大,特别是垂直编织花纹的方向上变形性较大,强度也较低,本实用新型为取其之长,避其之短,采用双层结构的绒线编织物,并且使双层绒线编织物的编织花纹相同或垂直,因而克服其不足,并且在鞋口处还增设了定型结构,这样使本实用新型的轻便鞋既保持一定形状和强度,还穿着舒适,透气,轻便,保暖,随脚和美观。

制作本实用新型的鞋,鞋底可选布底、皮革底、胶底、塑料底、及塑胶底等,按不同长度作成各种型号的鞋底,其肥瘦可取中型的,该实用新型的鞋面,可选用毛线、人造毛线、混仿毛线,用编织机或手工按大小号鞋的需要,编织成各种型号的鞋面,编织用的绒线可以是一种颜色,也可以是不同颜色,编织鞋面时,可以用平针,或其它针法编织成,也可编织图案,鞋面的鞋口处定型结构是采用与外层鞋面编织花纹不同方向的编
