The '773 patent and related U.S. Patent No. 8,562,341 are currently being asserted against Petitioner by licensee Dentsply International, Inc. and its wholly owned subsidiary Tulsa Dental Products LLC (d/b/a Tulsa Dental Specialties) in pending litigation filed on June 24, 2014 in the U.S. District Court for the Eastern District of Tennessee, No. 14-CV-196 (JRG). Additionally, Patent Owner Gold Standard Instruments, LLC ("Patent Owner") has filed four patent applications that claim priority to the '773 patent and so may be



affected by a decision in this proceeding: 14/522,013 (filed October 23, 2014); and 14/722,309, 14/722,390, and 14/722,840 (all filed May 27, 2015).

Petitioner is not aware of any other pending administrative matter that would affect, or be affected by, a decision in this proceeding.
