## **DECLARATION OF BENJAMIN BEIDEL**

- I, Benjamin Beidel, declare that:
- 1. I am over 18 years of age. I have personal knowledge of the facts stated in this Declaration and could testify competently to them if asked to do so.
  - 2. I received a Pharm. D. from Wilkes University in May 2013.
- 3. Since graduating from Wilkes University, I have been an active duty pharmacist with the United States Air Force, stationed at Lackland Air Force Base in San Antonio, Texas.
- 4. I am one of the authors on the Beidel article (B. Beidel, J. Bohan, C. D'Ippolito, E. Thudium, A. VanWert, H. Jacobs, and A.H. Kibbe, "Liquid dosage forms intended for pediatric use: Lisinopril & Meclizine," Department of Pharmaceutical Sciences, School of Pharmacy, Wilkes University, Wilkes-Barre, PA, presented at 2011 AAPS Annual Meeting and Exposition, October 26, 2011, Washington), which is attached to the accompanying petition for post-grant review as Exhibit 1005.
- 5. The Beidel poster was presented at the 2011 AAPS (American Association of Pharmaceutical Scientists) Annual Meeting and Exposition held on October 23-27, 2011 at the Walter E. Washington Convention Center in Washington, DC (hereinafter, "AAPS 2011").



- 6. I personally attended AAPS 2011. I brought the Beidel poster to the conference, and I put it on display. I was in attendance with the Beidel poster while it was on display at the conference. The conference was attended by numerous pharmacists, both academic pharmacists and industry pharmacists.
- 7. The Beidel poster was publicly displayed at AAPS 2011 on October 26, 2011 from 1:00 pm to 5:00 pm, or thereabout.
- 8. At the conference itself, the poster was large, approximately 3 feet by 4 feet. In order to display it, I pinned it to a board so that it could be easily viewed. It was displayed in an area where other posters were also on display.
- 9. I publicly attended AAPS 2011 next to the Beidel poster while it was on display. I answered questions posed by attendees regarding the poster and the lisinopril study disclosed in the poster. I spoke with approximately 15 to 20 people in total about the contents of the poster. I spoke with approximately 4 or 5 people in depth about the poster. For instance, I spoke with a Professor in a pharmaceutical science who had travelled from Germany about the poster. I also telephoned my co-author, Jefferson Bohan, to discuss questions on the lisinopril content of the poster posed by certain attendees, and their request for additional information.
- 10. The Beidel poster was also publicly displayed on May 1, 2012 at the Student Research Day at Wilkes University, School of Pharmacy, which was



attended by Professors and students from the School of Pharmacy, Wilkes University. I also personally attended the Student Research Day.
