### **DECLARATION OF JEFFERSON BOHAN**

- I, Jefferson Bohan, declare that:
- 1. I am over 18 years of age. I have personal knowledge of the facts stated in this Declaration and could testify competently to them if asked to do so.
- 2. I received a Doctor of Pharmacy degree from Wilkes University in May 2014.
- 3. From June 2014 until June 2015, I was a pharmacy resident at MaineGeneral Medical Center in Augusta, Maine. From June 2015 until the present, I have been an infectious diseases fellow at the Boise Veterans Affairs Medical Center in Boise, Idaho.
- 4. I am one of the authors on the Beidel poster (B. Beidel, J. Bohan, C. D'Ippolito, E. Thudium, A. VanWert, H. Jacobs, and A.H. Kibbe, "Liquid dosage forms intended for pediatric use: Lisinopril & Meclizine,"

  Department of Pharmaceutical Sciences, School of Pharmacy, Wilkes

  University, Wilkes-Barre, PA, presented at 2011 AAPS Annual Meeting and Exposition, October 26, 2011, Washington), which is attached to the accompanying petition for post-grant review as Exhibit 1005.
- 5. I am also one of the authors on the Beidel Two abstract, (A. Kibbe, A. VanWert, H. Jacobs, J. Bohan, B. Beidel "Lisinopril as a liquid dosage form



intended for pediatric use", Published Meeting Abstract, AAPS 2011. ("Beidel Two")), which is attached to the accompanying petition for post-grant review as Exhibit 1006.

- 6. In January 2011, along with Dr. Arthur Kibbe, (one of the authors of the Beidel poster and the Beidel Two abstract), I attended a Pediatric Trials Network symposium at Lai Lai Garden in Blue Bell, PA, a suburb of Philadelphia. At the event, which included academic pharmacy professors as well as pharmaceutical industry representatives, alternative medication formulations to capsules and tablets for pediatrics were discussed, as well as the need for stable liquid dosage forms of lisinopril.
- During the Spring 2011 semester, the studies disclosed in Beidel and Beidel Two were designed and the disclosed stability testing began. (*Id.*). During the 2011 summer break, before the testing results disclosed in the Beidel poster were complete, I personally drafted the abstract of the study (Beidel Two) in conjunction with the other authors. Dr. Arthur Kibbe submitted the Beidel Two abstract to AAPS for consideration for poster presentation at the upcoming AAPS 2011 conference in the fall of 2011.
- 8. During the Fall 2011 semester, the stability testing disclosed in the Beidel poster was completed before AAPS 2011 conference, and the generation of the Beidel poster was also completed before the AAPS 2011



conference.

- 9. The Beidel Two abstract significantly resembles the abstract that I prepared which was then submitted to AAPS in the spring/summer of 2011. My understanding is that the Beidel Two abstract has been publicly searchable and indexed via the AAPS website (www.aaps.org), via www.aaps.org → Publications → Published Meeting Abstracts → (search: lisinopril). (Ex. 1026). My understanding is that AAPS routinely publishes online abstracts from its annual meetings at or around the time of the conference. (Ex. 1026).
- 10. The Beidel poster was presented at the 2011 AAPS (American Association of Pharmaceutical Scientists) Annual Meeting and Exposition held on October 23-27, 2011 at the Walter E. Washington Convention Center in Washington, DC (hereinafter, "AAPS 2011"). During the conference, I was telephoned by my co-author, Benjamin Beidel, who was in attendance at the conference to present it. Mr. Beidel telephoned me to discuss questions regarding specific methods and/or results related to the lisinopril content of the poster posed by certain attendees, and their request for additional information.
- 11. The Beidel poster was also publicly displayed on May 1, 2012 at the Student Research Day at Wilkes University, School of Pharmacy, which was



attended by Professors and students from the School of Pharmacy, Wilkes University. I also personally attended the Student Research Day.

12. After presentation at both AAPS 2011 and Student Research Day, the poster remained publicly displayed on a hallway wall in the School of Pharmacy in Stark Learning Center at Wilkes University. I can confirm that the poster remained publicly displayed at least from May 2012 through May 2014 as I passed this poster regularly while I was attending Wilkes University.
