

The journal also prioritizes laboratory and animal studies of new drugs and molecule-targeted agents with the potential to lead to clinical trials, and studies of targetable mechanisms of oncogenesis, progression of the malignant phenotype, and metastatic disease.

Clinical Cancer Research is abstracted and/or indexed in MEDLINE, Index Medicus, Web of Science, Science Citation Index, Current Contents/Clinical Medicine, Chemical Abstracts, and Scopus.
