I, Cliff Harris, declare as follows:

1. I have personal knowledge of the facts stated in this Declaration, and if called as a witness, I could and would competently testify thereto.
2. I founded the video game company Positech Games Ltd., in 1997. My current role has been and continues to be the programmer and designer for all of the Positech games. I have one employee who assists me with programming and game design.
3. Gratuitous Space Battles (GSB) was released by Positech on November 17, 2009, and was available for purchase and download from the Positech website at <https://positech.co.uk/gratuitousspacebattles/>.
4. As of June 26, 2012, over 100,000 people had purchased GSB, and each copy purchased included a copy of a manual. In particular, Version 1.1 of the manual for GSB was provided to at least 100,000 purchasers by June 26, 2012, and was accessible online at <http://www.positech.co.uk/gratuitousspacebattles/media/GSB%20Manual.pdf>.
5. A correct representation of the manual for GSB is shown in Exhibit 1010 at pages 1-12.

7. These pages were accessible by the public and accessed by numerous users and purchasers as of June 26, 2012.
