**PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEE**

Petitioner requests a refund of \$31,900, the post-institution fee.

On September 21, 2020, Petitioner filed a Petition for *post grant* review (“PGR”) of U.S. Patent No. 10,653,719 and paid a filing fee of \$50,525, which included a \$18,625 request fee and a \$31,900 post-institution fee. On April 23, 2021, the Board denied institution of Petitioner’s PGR (Paper 11) and, on July 21, 2021, the Board denied Petitioner’s Request for Rehearing (Paper 13).
